Group Health and Safety Policy Statement

The Martin Group of Companies is committed to safeguarding the health, safety and welfare of our employees, supply chain partners and everyone else affected by our activities, as far as is reasonably practicable. The aims of our policy will be achieved by:

- Providing exemplary, visible leadership for health and safety,
- Pursuing every opportunity to identify and raise awareness of significant hazards and risks associated with our activities, implement control measures to eliminate the risks wherever reasonably practicable and reduce remaining risks to a tolerable level,
- Adhering to the relevant standards, statutory provisions and specific requirements of each industry in which we operate,
- Providing sufficient resources for the effective management of health and safety including compliance with this policy, setting and monitoring of objectives and implementing review programmes of our systems and processes for continual improvement,
- Integrating our supply chain partners into our management systems, ensuring our framework for safe delivery is applied consistently throughout all operations,
- Communicating with our employees, supply chain partners and clients to ensure everyone understands how to keep themselves and others safe and healthy,
- Provide such Information, Instruction, Training and Supervision to our people to ensure they are competent to carry out their roles safely,
- Consult and engage with our employees regularly on matters of health, safety and wellbeing.

It is the responsibility of every individual in the Group to:

- Perform their job in a safe manner, looking out for themselves and their colleagues,
- Stop and seek guidance if they believe what they are doing is unsafe,
- Report all accidents, incidents and near misses including unsafe acts or conditions,
- Comply with all health and safety requirements at all times and not to interfere with anything that has been provided in the interests of health & safety,
- Adopt positive, appropriate attitudes and behaviours towards all health and safety matters.

We will bring this policy to the attention of our employees, supply chain partners, clients and other relevant interested parties. It will be reviewed on an annual basis or after any significant change to our operations or relevant legislation.
